Community-Based Care Lead Agency Public Board Meeting

[Governor DeSantis' Executive Order Number 20-69](#) suspended the requirement of a quorum to be present in-person or that board members meet at a specific public place. The Executive Order also allows boards to utilize communications media technology, such as telephonic and video conferencing for public meetings. Additionally, [Governor DeSantis' Executive Order Number 20-91](#) directs all persons in the State of Florida to limit their movements and personal interactions outside of their home.

Each speaker is limited to three (3) minutes for such comments, unless additional time is approved by the Chairman at least 24 hours in advance of the meeting. Participants must announce their name before speaking.
